The Executive Minister led a discussion on priorities, based on the summary of points which were compiled at the October meeting of the Executive. The Executive Minister noted that much of the work on priorities is being undertaken by the committees of the region. The President, Elizabeth Stevenson, offered an update on the work of the Communities of Faith Growth Group. A video targeted towards welcoming newcomers has been prepared and will be presented at the annual meeting. Sue LeMaistre provided an update on the work of the Communications Group. One idea coming from a recent meeting of the group is to have teams of former presidents visiting clusters of congregations to form connections within the region. Work on updating the website is continuing. One new initiative added to the website is a listing of those available for pulpit supply. It was also noted that the Communications Group are also looking into providing education to connect with regional representatives.

The Executive Minister noted that some ministry groupings have grown organically in the region. Richard Bowley spoke about the group in Fredericton, and how these groups can be supported by the region and be formed in other areas where groups have not yet been formed. The Executive Minister also provided an update on the Health, Joy & Excellence Institute. Partners have been approached who may work with the region on offering programs for ministry personnel. Several partner meetings will be taking place in June after the annual meetings.

#### AFFIRM

#### Affirm Committee Report for April 17 Executive meeting 2024

Our committee members: Pix Butt (Chair), Tony Burnett, Janice Fairney, Don Scott (Secretary), Ross Sherwood, Elizabeth Stevenson.

We were happy to welcome new member, Janice Fairney to the committee last month.

In February we had a special meeting of our committee to respond to the Affirm United call to action regarding "An urgent response to legislative hatred toward Trans youth." From our discussion:

- encourage participation in a rally or demonstration if the opportunity arose. (since this meeting some have taken a zoom workshop on how to successfully and safely be part of a counter protest)
- an announcement was sent out through the region with information on organization that we can support in their work (ex: EGALE, Peers on PEI; Chroma NB or to similar groups.)
- it was thought at the time that PEI was a safer place since legislation has not been brought in like that in NB and Alberta. However, since the meeting we've learned our regulations are not strong. We all need to be vigilant.
- A suggestion to have a safe space at our Annual Meeting for LGBT2S+ people to gather. Unfortunately, no such space seems available in our meeting space this year. This could be noted as something to look for when AGM space is being sought.
- A suggestion to have a Zoom space for LGBT2S+ UCC people to gather. This led to consideration of supports for our UCC ministry personnel. Faith is checking with National Church to see what might be in place. Although we have many areas where people feel safe to be out, there are still places where they do not. This adds to the sensitivity needed in offering support.
- We need a point person from our committee to link with Affirm United. Tony Burnet has taken on that role.

We continue to offer webinars. Just before our last meeting we had Dawn O'Dell from Mental Health New Brunswick share some basics in looking after our own mental health. This session is NOT available on our Resource page.

This was followed by a webinar with Kelly Hudson-Lewis, who is a UCC minister and a Spiritual Care Practitioner. Kelly is the Manager of Spiritual Care Department for Saint John area of Horizon Health. Kelly helped us locate mental health support in a more spiritual context. This session can be found on the Resource page of FSLDW.

Our next webinar on April 18th is one we repeat each year, helping people and congregations get started on their discussions and plans for becoming an Affirming congregation. Our guest will be Kim Curlett, UCC ministry personnel and Affirm United representative for our maritime Regions. Watch for registration on the weekly announcements. This is a great way to have some questions answered and hear what other congregations are doing in their processes toward becoming Affirming.

We heard of several congregations planning P.I.E. day activities on March 14<sup>th</sup> (Public, Intentional, Explicit). It is good to see energy around these LBGT2SQ+ events which are supportive and educational.

We have also begun planning for our AGM workshop.

On behalf of the Maritime United Church Women, we would like to thank Regional Councils for their continued support of the Maritime United Church Woman (MUCW). Since last submitting a report to the Regional Councils in January the Maritime UCW Executive held our regular quarterly meeting on February 12th and two Annual Planning Committee meetings January 15th, February 27th with one planned for April 18th. All meetings were held over zoom.

The 2023 statistical forms that were sent out in December and January are slowly trickling in. If your Community of Faith's UCW has not completed theirs, please encourage them to send it in asap. Our Regional UCW Statistics are due into the National UCW the end of June. In efforts to streamline the process, we are asking that both statistics and annual dues of \$4 each member (\$3 going to Maritime and \$1 to National) be mailed directly to our secretary Ruth Kennedy. For those UCW women who no longer have an active UCW unit, individual membership is available through our secretary.

Maritime UCW February/March newsletter has been published and was circulated online and those with subscription would have been received by mail. It will be available on the UCW page on the regional websites. Keeping in Touch, the National UCW Newsletter issue 9 - January 2024 is now posted National UCW website.

Fundraising for our National United Church Women Five Year Project to the Healing Fund -continues with \$28,383.77 being donated up to January 31st, 2024.

A great deal of our focus this spring has been the planning of our annual meeting which will take place at St. James United Church in Antigonish, NS from April 26<sup>th</sup> to 28<sup>th</sup>. Registration forms have been circulated via email and are available on the regional websites under Ministries - United Church Women as well as in our February newsletter. Rev. Janice MacLean from Prayer Bench ministries will help us explore our theme "PASS ON BEAUTY" Spiritual Practices for These Times and we are so pleased to welcome guests from our Regional Councils, our Executive Minister, Rev. Faith March-MacCuish, President Elect of Fundy St. Lawrence Dawning Waters (FSLDW), Rev. Sue LeMaistre and President Elect of Bermuda-NS, Rev. Donna Tourneur. The Annual meeting is open to all UCW, and we do hope to have good representation from throughout the two regions. # ARCHIVES AND RECORDS

New Terms of Reference Archives and Records Committee Fundy St. Lawrence Dawning Waters April 2024

Mission: To provide leadership, education and support to Communities of Faith in matters related to archives, records, artefacts and heritage.

Responsibilities:

- A) To provide information and education about archives, records, artefacts and heritage in the United Church to Communities of Faith. This will mainly be accomplished through workshops, correspondence and, where practicable, the occasional visit to individual communities of faith.
- B) To support the archivist in matters related to archives, artefacts and heritage in ways that the archivist deems appropriate.
- C) To report annually on the committee's work and expenditures.
- D) To find innovative ways to share information about United Church history with communities of faith, adherents and members. Sometimes working in conjunction with Nova Scotia-Bermuda and, possibly, other regions and the denomination where applicable.

# JUSTICE, MISSION AND OUTREACH

#### Justice, Mission, and Outreach Committee April 2024

JMOC met virtually on February 13 to complete business from the Fall Gathering:

- i) budget
- ii) committee membership
- Refugee and Newcomer Representative iii)
- iv) JMOC's relationship with First Dawn Eastern Edge's JMOC
- Logo for JMOC V)
- vi) Request for JMOC decision regarding support for private member of parliament's Bill S-210 (Young persons' exposure to pornography Act) JMOC decided to not support the Bill.
- vii) Updating JMOC website
- Plenary time and Workshops for Working Groups at AGMs viii)

At this meeting, it was agreed that JMOC co-chairs meet with chairs of B-NS and FSLDW's nominating committees in March to discuss membership. As a bi-regional committee consisting of chairs (or their delegates) of working groups as well as members at large, JMOC needs to ensure the nominations committees are clear on who our membership is. Working group chairs can shift from region to region and nominations may not be aware.

JMOC's next meeting is a Zoom meeting on April 16, 2024 to plan for the annual meetings.

#### **Working Group Activities**

Eco-Justice, Just Peace in Israel and Palestine, Guaranteed Livable Income, and Mental Health Working Groups have regular monthly meetings throughout the year.

#### **Guaranteed Living Income**

The Atlantic provinces' four GLI groups belong to a nation-wide UCC network of provincial groups which have advocated for GLI for many years. Although GLI group members have been affiliated with JMOC for some time, GLI has only been a Working Group under the JMOC umbrella since the Fall Gathering.

#### **Eco-Justice**

The Eco-Justice working group has worked to increase collaboration with other climate justice groups. already partnering with KAIROS-Halifax, Faith and the Common Good and the Ecology Action Centre. They have begun the process of creating an Interfaith Coalition on Climate Change.

Some of Eco-Justice's activities:

- 1. requested JMOC's financial support and letter support for the 5 environmental activists in El Salvador arrested because of their leadership in resisting mining in El Salvador.
- 2. used Regional Council Announcements to invite those working on climate justice in communities of faith to join their network of Green Enthusiasts in UCC-East. The Working Group wants to engage Green Enthusiasts in a two-way exchange of information and enthusiasm.
- 3. arranged for Sarah Gingles, a student at Queen's University and youth participant at COP28 in Dubai, to present at the Annual meeting.
- participated in webinar to learn about EV Charging Stations for church parking lots 4 and discussed sharing stories of local EV users.

#### Just Peace in Israel and Palestine

This group has been very active since Israel's declaration of war on Hamas. The content of media reports and Canada's pro-Israel actions gave a new urgency to deepening people's understanding of antisemitism and anti-Palestinian prejudices.

The Working Group's actions to promote justice in Israel and Gaza include:

1. providing Palestine Land Exercise events and training facilitators

- 2. letter writing urging General Council to call upon Canada to continue to call for an immediate and sustainable ceasefire; refund UNRWA; support South Africa's justice for Palestine case before the International Court; stop supplying military equipment to Israel
- 3. Urging individuals and communities of faith to be part of letter writing and petition signing campaigns in the direction of the federal government
- 4. Hosting" Just Peace Candles" during Lent
- 5. organizing book study The Other Side of the Wall by Munther Issac.

Just Peace in Israel and Palestine will have a presentation and two Workshops at the Annual Meeting.

# **Mental Health**

This working group has supported:

- Regional Councils hiring a part-time person to support congregations in dealing 1. with problems of mental challenges.
- 2. Working with congregational clusters. With support from Rev. Shepherd and the cooperation of clergy in the Miramichi area, the first mental health cluster event is being organized. Clergy have joined the Working Group in several Zoom Rooms meetings to plan a Mental Health Awareness event for Saturday May 4<sup>th</sup>. The event is intended to be a time of fellowship, getting to know one another, learning and encouragement.

#### Indigenous Rights and Relations Working Group

JMOC had an active Indigenous Working Group in the past and is committed to revitalizing this. Rev. Shepherd is assisting in connecting with First Nations for guidance.

#### PASTORAL RELATIONS

#### Fundy St. Lawrence Dawning Waters Regional Council Pastoral Relations Committee Report to the Executive April 2024

Greetings and peace from the members of your Pastoral Relations Committee.

The committee met twice since our last regular Executive meeting in October. These meetings were held on February and March 12, 2024. Another meeting will be held on April 9. More information and documents may be delivered prior to the Executive meeting because of actions from this April 9 committee meeting. Motions and major actions continue to be published in the weekly announcements.

The Committee and Working Groups continue to work on resource materials and documents to assist ministry personnel and communities of faith. Ongoing projects in various stages of completion include:

- Self-Assessment: 11 communities are currently engaged in further testing of the assessments this year. The Self Assessment Working Group will meet on April 10 at 2 pm to review the responses received to date. Most communities seem to be struggling somewhat to complete the assignment and the group will discuss this issue and possible solutions.
- Community of Faith Profiles: A flow chart outlining the step-by-step process through the profile and search processes for liaisons and communities of faith has been completed, an expedited process has been developed by the committee to internally streamline the final approval process and a template to assist communities is the development of the essential elements of the profile will be presented to the PR Committee in April.
- The Pensioner Working Group continues to meet and develop the framework for a
  pastoral approach to the pensioner community.
- The committee has approved the provisional call process for DLMs seeking testamur as per the recommendation of the national church.
- Sacraments Elder Training is being developed for a spring training session in Sackville. A draft Sacraments Elder Policy is in review in committee.
- Pastoral Relations and Property have been working with Kendall to coordinate and record the steps associated with the legal closure of a community of faith or pastoral charge. A draft is being reviewed for the PR Committee April meeting. We also continue to follow a growing list of communities and charges in various states of closure.
- An information document called Considerations for Part-Time Ministry has been developed and approved by the PR Committee. It is also presented here for your review following which it will be posted on the FSLDW Website.
- A list of trained liaisons has been created to assist internally in the assignment of
  pastoral relations liaisons for profile development.
- Informational Administration Sheets have been created to assist liaisons and pastoral charge supervisors understanding or their responsibilities and managing expenses.
- LLWL Boundaries Training continues to be developed and should be available for fall.
- A general Provisional Call policy (non DLM) draft is in review in the committee.
- We are following closely discussions about ministry collaboration, review and change in several communities.

There continues to be significant change in the ranks of ministry personnel in some communities (movement and retirement) and long search processes continue for some. The committee wishes to recognize retired ministry personnel who have stepped forward to accept appointments providing ministry to many communities as well as providing pastoral charge supervision in others. Without their commitment we would be in a much more difficult situation.

We also wish to commend our LLWL community and lay leaders who continue to offer worship leadership in many communities allowing for sabbaticals, holidays, sick leave and emergency leave.

#### **PASTORAL RELATIONS** - continued

The committee continues to work on the following issues as part of our workplan.

- A review of mission churches, seasonal, and inactive communities, pastoral change  $\geq$ names and pastoral charge composition. This is on hold until website updating is complete and decision made on what to display publicly.
- A review of our website documents to make the documents more noticeable as the  $\triangleright$ number grows and we coordinate with the region and other committees.
- $\triangleright$ Participation regional efforts to improve communications between our pastoral charges and the Region.

There are currently (as of March 26, 2024) 12 charges in approved search, 13 preparing profiles, one in discernment of its future and 8 longer term vacancies. We also currently have 31 communities requiring Pastoral Charge Supervision on a temporary or longer-term basis. Barbara Prowse continues to work continuously with our LLWL folk as their Regional Coordinator.

As always sincere thanks are extended to our committee members, working groups and our Regional Minister, Rev. Kendall Harrison for their dedication to this work.

This will likely constitute my last report to the Executive Committee as chair of Pastoral Relations. I wish to thank the Executive Minister and various Executives committees for their support over the past 5 years. In addition, my gratitude is extended to all present and former Pastoral Relations committee and working group members for their cooperation, collaboration and diligence as we have slowly but solidly grown into our new regional governance structure. Special thanks go to Marlene MacLeod whose solid administrative and correspondence skills as secretary have been most appreciated. She will also leave the committee and the end of the annual meeting, and we are happy to welcome Nancy Nicol as her replacement in that role. I am also indebted to the Rev. Kendall Harrison for his support, guidance, patience, and humour as we have travelled this journey together.

May God continue to bless you all in this important piece of ministry.
