Toward 2035

The Executive Minister, Faith March-MacCuish, began the discussion on Toward 2035 with a presentation to the executive members gathered. The Toward 2035 initiative of the General Council is focused on taking seriously the call to love our neighbours and embrace the strategic plan for deep spirituality, bold discipleship and daring justice. Data has been collected from 1991-2023, and an expected trajectory towards 2035, with the hope that we will interrupt the trajectory and create the church we want to have in 2035; paying attention to strategically making sure we have a United Church presence in geographical areas across the country. The General Council hopes this report will lead to positive changes in places where there are United Churches. It will be a collaborative initiative of the General Council, Regional Councils and congregations.

Toward 2035

In the second phase of the discussion and presentation, the Executive Minister presented the data breakdown for the denomination, where multiple points of data have been collected from the denominational statistics, Statistics Canada and Environics Research Group. This overview helps us to see the denomination as a whole, using data that is available to us. There are 1898 (one thousand eight hundred and ninety-eight) pastoral charges as created in Dynamics, and this data helps us to see the average picture of the denomination. The data was not surprising as it reflects what we have been experiencing in our own regions and pastoral charges.

**TOWARD 2035** - continued

The third phase of the Toward 2035 presentation was to discuss and look at our regional council and the strategies we will use to help support our congregations and leaders into 2035. Some of our agreed ways forward were to:

- seek to realize a vision of resilient, inspired, diverse United Church communities of disciples across our region; urban and rural; in a multigenerational denomination
- support congregations in their vitality
- support ministry leaders in faithful, adaptive and effective leadership
- support lay leadership within pastoral charges in faithful, adaptive and effective leadership
- support evidence-based implementation and active experimentation (collaborative and cooperative incentives, with a process for evaluation of what we have learned collectively)

With the goal of supporting resilient, inspired, vital communities of faith, we also realize that there will be congregations for which there is a need to help with ending well. It was agreed that we will need a strong process of support.

**REGIONAL COUNCIL EVALUATION**

The Executive Minister, Faith March-MacCuish, presented the final report on the evaluation of the regional council structure, including the background, key findings and recommendations, as prepared by Jenny Stephens, consultant for the review. The consultant began the evaluation report with scripture from 1 Peter 2:5a *Living Stones*.

Over the course of the evaluation, the consultant completed surveys, attended meetings, and reviewed minutes, newsletters and governance documents. The consultant noted that, while there was not a particularly strong response to the surveys, the surveys did provide important data for the evaluation.

The final report detailed that there is a significant change curve in emotional response that occurs with major change. The 2019 restructuring of the United Church caused great disruption, resulting in fear and resistance. Recovery from disruption takes time to recover from, before acceptance and openness brings confidence in the new.

#### **Report of the decisions and discussion items before the Division:**

The review of Annual Reports was discussed by the Division. It was felt that some time was needed to plan and promote this event. It seems more reasonable to hold the event in the spring after the 2025 Annual Reports have been submitted to the Region.

The Division of Ministry Resources would like to hold an information session for all committee members in the Division regarding the "Towards 2035". Many of the slides that were shown at the last Executive meeting related to the work of several committees within this Division.

There was a discussion about churches wanting to change from full-time to part-time ministry. Examples were given about churches that had re-vitalized. It was suggested that 'vibrant' ministries support struggling churches that show some potential by sharing their strategies and stories of success through meetings, Zoom sessions or a video. Discussion was had regarding ways that we may offer guidance and support for congregations to ensure that ministry continues amidst mass decline and closure, and to ensure that resources are being used to support growth and renewal, rather than just paying the bills to keep the building operating.

#### **Dates of Committee Meetings:** (since last Executive meeting)

Future Directions – none. The Committee is without a chair.

Retiree Support – none.

Pastoral Relations – June 27, July 18, September 5, October 17

Faith Story & Community Covenant – none. The Committee is without a chair.

Licensing – June 14, October 9

#### **Reports of the decisions and discussion items from the Committees:**

**Future Directions:** There is presently only one member on this Committee. The Division discussed an issue referred to the Future Directions Committee from the Pastoral Relations Committee.

**Retiree Support:** At the rise of the annual meeting, Ruth Gamble became the chair of the Retiree Support Committee. She has sent an email to the current group of retirees. She plans to send a message through the weekly announcements in the fall, advising people in the region of this committee and inviting people to get in touch with her. Ruth is working on a possible cluster meeting within the Halifax or Truro area.

**Pastoral Relations:** The actions of the Pastoral Relations Committee are reported each month in the weekly announcements of the Region. Many of the decisions are made by email in between the monthly meetings. This practice does not leave pastoral charges waiting for a decision.

**Faith Story & Community Covenant:** This committee does not have a chairperson. The Division discussed the Annual Report Review and decided to aim to begin this review in the spring of 2026.

**MINISTRY RESOURCES** - continued

**Licensing:** The Licensing Committee met in person on June 14 at Woodlawn United Church. Sandi Irving was welcomed as a new member to this committee. Several matters regarding Sacraments Elders, Licensed Lay Worship Leaders and licenses for sacraments and marriage were discussed. It was agreed that this committee should keep a record of "Policies and Procedures". A script of questions for the first-year check-in of a Licensed Lay Worship Leader was approved. "Suggested Questions for Interviewing Candidates for Sacraments and/or Marriage License Privileges" was also approved as a template for interviewing these candidates. The Committee remains interested in conducting a workshop on Licensed Lay Worship Leaders at the 2026 Annual Meeting. Discussion continues on recognizing Licensed Lay Worship Leaders at the Annual Meeting and the question of whether they can conduct funerals outside their own pastoral charge. Several changes to the Licensed Lay Worship Leader Policy of the Region will be suggested. It was also noted that it is not appropriate for Licensed Lay Worship Leaders to wear a stole. Three Licensed Lay Worship Leaders were interviewed and approved to be re-licensed for three years – Tim Aggett, Lisa Clarke and Susan Reid. Plans are underway for a LLWL Gathering in the fall. This will be a joint event with the Fundy St. Lawrence – Dawning Waters Region. Another LLWL interview was conducted on Zoom and the license of Sara Mattinson was renewed for three years. At the meeting on October 9, the LLWL Event (November 6 & 7) in Tatamagouche was discussed.

Two of our committees do not have chairpersons. Many of the committees could use more people.

- Work with Brunswick Street United Church in Halifax continues; the congregation has not yet disbanded as the transferring of assets into a trust is still in progress

Incorporated Ministries

Property

- The committee has been working with St. Paul's United Church in Spryfield for the past 6 months or so, in an effort to place the building and property under a Regional Trust rather than putting it up for sale. The work is nearing completion but for a bit of legal work still in progress.
- recently St. Paul's has been operating on an overdraft; fundraising and a campaign have brought them out of overdraft, but the community of faith now lacks energy to keep moving forward and wish instead to close and disband. The church has lost its charity status and are following up with CRA to have that reinstated.
- St. Paul's has a Resource Centre & Food Bank located in the lower level of the church building that plays an important role in the community and contributes monthly to the church's finances
- The trustees engaged the NS Provincial Housing Authority re. using the property to develop affordable housing and provide space for community programming. An MOU was drafted between St. Paul's & HRM
- The MOU has not been signed and it was agreed instead to move the building into the Regional Trust. Wally Chivers & Dave Hewitt have been investigating the process re. the Trust and also working with the folks at St. Paul's to determine their future ministry
- Wally is also in contact with UPRC regarding possible management of the building; it is understood that Kindred Works does not see the location as viable for the redevelopment into housing
- The Property Committee recently approved a motion to authorize Faith March-MacCuish to sign and complete setting up the Regional Trust to hold property within Bermuda-Nova Scotia Region.

MOTION by April Hart that Bermuda-Nova Scotia Region authorize the Executive Minister to move St. Paul's United Church, Spryfield, into the Regional Trust.

The Chair, Sandra Tomsons reported.  
September, 2025

JMOC has not met since the in-person meeting on May 29, 2025.

JMOC has a full roster (9) of members from FSLDW. There are still 5 vacancies for B-NS. A new member-at-large from B-NS has been recruited, but he is moving soon to New Brunswick. Kathy and I are working with the nominating committees from each region to determine how to handle this situation.

The Campus Chaplaincy issue is being actively explored by JMOC. This concern was brought to JMOC by the Bermuda-Nova-Scotia region after the Dalhousie Chaplaincy position ended. Rev. Natasha Pearen and Rev. Jenn Broomhead have developed a proposal that involves churches in the area of Dalhousie campus providing support to students. JMOC recognizes this issue is not limited to Dalhousie.

JMOC will be holding its annual in-person meeting at Tatamagouche October 23-24, 2025. We will be looking at using cluster gatherings to engage with communities of faith and help build local justice interest and capacity.

**Updates from Working Groups:**

**Indigenous Rights and Relations**

JMOC does not have an active working group for Indigenous Rights and Relations so continues with a "whole of JMOC approach." B-NS region has asked JMOC for a webinar on Land Acknowledgements and we are following up on this.

JMOC, along with Women of First Light, co-sponsored a spring book launch tour by Marie Wilson to introduce North of Nowhere: Song of a Truth and Reconciliation Commissioner. With JMOC support, Marie was able to speak to large audiences in Halifax, Mahone Bay, Sydney, Antigonish, Pictou, Truro, Tatamagouche, Charlottetown, Fredericton, Sackville and Moncton. In some locations United Churches collaborated with community groups to support these events. JMOC is now urging follow-up to this tour by encouraging local United Churches to find ways to enact the United Church Apology. These include book studies, participating collectively in the Sept. 30th National Day of Reconciliation, and developing relationships with Wabanaki communities (Mi'kmaq, Wolastoqey, Passamaquoddy).

**Just Peace**

Teams continue to offer the Palestine Land Exercise (PLE). A group was trained recently in Saint John to provide the program. On PEI, the PLE Team provided the program earlier this year and has another booked for the fall.

JMOC endorsed a call to cancel the Davis Cup matches planned for Halifax this Fall. The issue is the presence of Israeli athletes at a time when the government of Israel is engaged in genocide in Gaza. Against a background of acceptance in sport, regardless of politics, there is also a history of sport speaking loudly against repression as happened with bans on South Africa during the Apartheid Era.

**Just Peace Working Group Update September 2025**

Since our last report to the region in April we:

1. Have responded to the desperate calls for solidarity and support from local neighbours whose families are in constant danger in Gaza.

a) Islam Elbatie anxiously approached us for help when his siblings in Gaza found access to food scarce, difficult to access, and very expensive. Islam's resources are limited. He knew that we had previously raised money for a family whose home was damaged from Israel's bombing of Gaza in 2014. We organized a team to provide a lunch and Islam shared his personal story to people who came. Four churches hosted a Fundraiser for Gaza Relief. We raised over \$5,000 Ca which was sent to Islam's family in Gaza. Some still want to give.

b) Over a year and a half ago, Najlaa applied for her family to be able to come to Canada through the federal government's Gazan Special Immigration Measures Program to reunite families. As time passes and dangers increase for her family in Gaza, she continues to advocate for her family's approval. The Minister with this portfolio has not agreed to meet with Najlaa or others in her situation. She has asked supporters to stand with them in solidarity and to show support until there is a positive response. We have written letters to the Minister and joined rallies in support of Najlaa's efforts.

c) Helmi, in St John, NB, has been speaking up for justice for Palestinians and asked for our support in educating Canadians. We responded by leading the Palestine Land Exercise for a group of church and community people in St John and agreed to work together in co-sponsoring a film series in the fall.

2. We continue to promote and sell Zatoun Fair Trade Palestinian olive oil and Zatar which supports Palestinian farmers, justice and peace.

3. We continue to educate church members and to encourage their advocacy.

a) We have been promoting and leading the Palestine Land Exercise in churches in both of our regions and supporting PLE leadership teams in other parts of Canada who we trained last year in Toronto. We have begun conversations with the United Church of Christ and Disciples of Christ Churches in the USA and Canada about training teams to lead the PLE for them to use in their home areas.

b) We have been spreading the word about the United Church Justice Principles and encouragement to participate in BDS (Boycott, Divestment and Sanctions) and to sign the Pledge to be Apartheid-Free Communities.

c) We have been sending letters and signing petitions to the Prime Minister, the Minister of Foreign Affairs, and other Canadian government officials urging them to take urgent actions such as to:

- Secure an immediate and permanent ceasefire;
- Ensure food, water, fuel, and humanitarian aid are delivered unhindered;
- Achieve the release of all captives, both Israeli and Palestinian;
- Impose a comprehensive, two-way arms embargo on Israel, including closing loopholes such as exports via the US;
- End Israel's military occupation and annexation of Palestine, paving the way for a just peace.

d) We have been signing petitions and sending letters against allowing Israel's team of military veterans of genocidal violence to play in the Davis Cup in Halifax, Canada in September.

4. We believe in following the lead and amplifying the voices of key Palestinian partners in our advocacy work especially Kairos Palestine and the Sabeel Ecumenical Liberation Theology Center. We maintain close ties with leading and credible Palestinian advocacy groups in Canada including United Network for Justice and Peace in Palestine and Israel, Canadian Friends of Sabeel, and Canadians for Justice and Peace in the Middle East.

Kairos Palestine, a United Church of Canada partner, named the development of a Post Gaza Theology as one of their key priorities in their strategic plan. In response, the Just Peace Working group wrote a proposal that was adopted by both regions and forwarded to General Council in support of the development of a Task Group in the United Church to work on this issue.

The proposals submitted to GC45 have not yet been voted on. They will be dealt with at a special meeting in September. This includes the proposal for development of a post Gaza theology.

5. GC45 closing statement:

The genocide in Gaza has reached unimaginable horror. On August 7, 2025, Israeli Prime Minister Benjamin Netanyahu declared his government's plan to occupy Gaza, confirming decades of warnings from Palestinian communities. This comes amid the deliberate deprivation of food, the weaponization of aid, and the destruction of hospitals, schools, water systems, and homes. Families have been displaced repeatedly, children are dying of starvation, and communities lack clean water, medical care, and safe shelter. These crimes against humanity demand our moral response as people of faith. We cannot remain silent as the survival of Palestinians in Gaza hangs in the balance.

The United Church of Canada:

- Calls upon the Government of Canada to prioritize the protection of civilian life, ensure unimpeded humanitarian access, impose a comprehensive, two-way arms embargo on Israel, including closing loopholes such as exports via the U.S., ensure security for journalists and humanitarian aid workers, and work toward sustainable peace that honors the dignity and rights of all people in the region.
- Commits itself to prayer, advocacy, and concrete action to support those in need and to work for the day when Palestinians and Israelis alike can grow up in safety, security, and hope alongside one another, and calls on all people of faith and goodwill to do the same.

6. Since the conclusion of GC45: a famine has been officially declared in North Gaza. Israel denies the reality of famine and is prepared to begin an offensive invasion and take over of North Gaza forcing Palestinians to leave and not be able to return - since Israel aims to totally destroy all structures.

Palestinians are begging the international community for protection.

We support advocacy for the Canadian government to take urgent and stronger actions to protect the lives and future of Palestinians.

**Mental Health**

Rev. Chris MacLeod, currently a member at large on JMOC, has agreed to provide leadership for this working group.
